

Banks Township Board Regular Meeting

April 19, 1993

held at the Banks Township Hall, Ellsworth, Michigan

1. The meeting was called to order by the Supervisor Daniel Wieland at 8:45 PM, following the Annual Meeting. Board members present included Supervisor Wieland, Clerk Donna Heeres, Treasurer Jacob Veenstra, Trustees Peter VanderArk and Gary Strange. Also present Fire Chief Bruce Chellis, Jerry Rasmussen, John Hastings arrived at 9:00 PM.
2. The minutes of the March meeting were read. MOTION VanderArk, Strange, CARRIED to approve the minutes as presented.
3. The Treasurer's Report of Incomes and Balances was given.
4. Fire Dept: Chief Chellis report was presented and filed in the Fire Board minutes. MOTION Wieland, VanderArk, CARRIED to renew the Motorola contract with portables, mobiles, & pagers for \$1632 per year, 2/15/93 thru \$2/14/94. MOTION VanderArk, Veenstra, Carried, to pay rescue, pictures, training meals, computer, gas, equipment as outlined in the fire minutes. Drunk Driving Ordinance: Correspondence from Risk Manager was reviewed, he recommends not adopting this ordinance. MOTION Strange, Heeres, CARRIED to table. Work Comp Insurance: Audit has shown Fire Fund owes, General Fund has balance. MOTION Strange, Wieland, CARRIED to move \$109.89 from Fire to General to reflect this. Old Grass Rig was discussed and its need for a new pump. MOTION Strange, Wieland, FAILED to purchase pump & hose for \$600. MOTION Heeres, Veenstra, CARRIED to purchase acid & stain and obtain 2 bids for paving the new fire hall driveway. MOTION VanderArk, Wieland, CARRIED to purchase portable pump for not more than \$1975 plus freight.
5. Old Fire Hall Sale: Problems with deed being registered to Watrous and Banks Twp. for the SW 1/4. Strange will obtain quit claim deed from Pat Dillon, former owner, and Cliff Watrous, to convey to the Township. Expect closing this week. MOTION Veenstra, VanderArk, CARRIED to give the Supervisor the authority to sign the sale agreement for the sale of the Township's interest in the South 1/2 of Lot 132.
6. Supervisor Report: Attended a 2 1/2 day workshop that was beneficial to him. Board of Review met a total of 3 days and 2 evenings. Assessing materials from John Knorr are coming in. Clean Up letter to be sent out for June 12 clean up day. Recognition plaques for John Elzinga and Willard VanderArk to be presented at the Safety Meeting.
7. Clerk's report: MTA District Meeting to be held May 24 in Traverse City. Wieland, Heeres, VanderArk, Strange to attend. DNR report was shared. Planning Commission meeting for April 28 has been cancelled. Zoning violations update from Jim Young was shared.
8. Bills represented by the attached list were presented for

approval for payment. MOTION Wieland, VanderArk, CARRIED to pay the bills as presented.

9. The meeting was adjourned at 11:40 PM.
