

Banks Township Board Regular Meeting

April 17, 1995

held at the Banks Township Hall, Ellsworth, Michigan

1. The meeting was called to order by the Supervisor Daniel Wieland at 7:42 PM, following the Annual Meeting. Board members present included Supervisor Wieland, Clerk Donna Heeres, Treasurer Jacob Veenstra, Trustees Peter VanderArk and Gary Strange. Also Mark Groenink, Eric Wisniewski of the Antrim County News, Janet Person of the Soil Conservation Office, Jerry Rasmussen.

2. The minutes of the March regular meeting were reviewed. MOTION VanderArk, Wieland, CARRIED to approve the minutes as presented.

3. The Treasurer's Report of Incomes and Balances was given. General Fund: \$187,414.56; Fire Fund: \$75,735.73; Vehicle Fund: \$12,503.00; Liquor Fund: \$2,482.50; Grand Total: \$278,135.79.

4. Janet Person addressed the Board re: the Antrim Soil Conservation Service proposed amendment to the Soil Erosion and Storm Water Runoff Control Ordinance. A Public Hearing will be held at the Commissioners Meeting on May 11.

5. No meeting of the Fire Board this month. The Board reviewed plans for new firehall in Atwood. Strange was appointed to have plans reviewed by another designer and have some questions addressed. He was authorized to hire an architect to get the plans sealed prior to proceeding with advertisement for construction bids. If cost is to exceed \$500, a special meeting will be called prior to the hiring. Chief informed the Board of need of replacement coat for a fireman. Cost to be \$216.

6. Planning Commission: Strange reported on Drenth Rezoning request and Public Hearing held March 30. Action on the request was tabled until the April 13 Regular Meeting to allow more research. At the April 13 meeting, the request was approved with restrictions and sent to the Antrim County Planning Commission for review. Performance guarantee was discussed to provide assurance of reclamation. Letter of resignation was submitted for Charles Warner who resigned due to no longer owning property within the Township. No written resignation from Jack Danbert yet. Letter from the Zoning Administrator re: status of Blight Ordinance violations was read. The Z.A. has sent to Township Attorney for further action.

7. MTA County Chapter (Charlevoix) Minutes were reviewed and the Supervisor updated the Board on the March 27 meeting. Antrim County Townships are banding together to form an Antrim County Chapter of MTA. A meeting will be held on April

25 a t 7 P.M. at the Torch Lake Township Hall in Eastport.
MTA Spring District meetings coming up in May.

8. Banks Township Community Center Board Appointments were made: Chester Drenth, Rusty McIntosh, Joni Wieland, Mary Peterson, Donna Heeres and their designees. MOTION Strange, VanderArk, CARRIED to contribute \$400 to the BTCC for the 1995 Pig Roast activities. \$250 to be used for Tent Rental, \$150 at the discretion of the committee.

9. MOTION VanderArk, Wieland, CARRIED to purchase an LX178 mower for the cemeteries/Park for \$3550.

10. Bills represented by the attached list were presented for approval for payment. MOTION Strange, Heeres, CARRIED to pay the bills as presented.

11. The meeting was adjourned at 9:00 PM.
