

Banks Township Board Regular Meeting
August 17, 1996
held at the Banks Township Hall, Ellsworth, Michigan

1. The meeting was called to order by the Supervisor Daniel Wieland at 7:30 PM. Board members present included Supervisor Wieland, Clerk Donna Heeres, Treasurer Jacob Veenstra, Trustee Gary Strange and Trustee Peter VanderArk. Also present: Mark Groenink.
2. The minutes of the July regular meeting were reviewed. MOTION Strange, Wieland, CARRIED to approve the minutes as presented.
3. The Treasurer's report of Incomes and Balances was given. General Fund: \$185,503.997 Fire Fund: \$19,428.27; Vehicle Fund: \$12,878.00; Liquor Fund: \$3,140.00; Grand Total: \$220,950.24.
4. Public Comment: None.
5. Fire Dept.: No Fire Board meeting this month. Ambulance service: investigation of rates for both Charlevoix and East Jordan continues. Estimated at .1 mill per year. This would allow "resident rates" for users and amounts to about one half the "non-resident rate".
6. Roads: Antrim Dells Road: Response from Antrim Dells Association: They are not willing to commit funds for improvements to a public road. Road Millage: Resolution was offered by Strange, supported by Wieland to place a proposal on the November General Election Ballot requesting up to 1.5 mill per year for eight years. Roll Call Vote: Wieland: Yes; Heeres: Yes; Veenstra: Yes; VanderArk: Yes; Strange: Yes. Resolution declared adopted.
7. Antrim County Planning Commission: Supervisor reports he was contacted with a request for nominees for the commission from Banks Township. Will offer Everett Nienhouse.
8. Antrim Creek Natural Area: last meeting of the management group centered on Fund Raising and closure of Rex Beech Road Extension.
9. Announcements: Road Management Workshop: Sponsored by MTA in Gaylord on August 27. Will try to send 1 or 2 representatives. MSU Extension Workshop on Planning & Zoning Sept 17 7PM at Shanty Creek. Charlevoix County Chapter MTA Aug 26 at Evangeline Twp Hall with Evelyn David of MTA. Antrim County Chapter MTA Aug 27 at Milton Twp Hall with Evelyn David also.
10. Wetlands Applications: Donald Binns, Thomas Cooper (2) and Antrim County Road Commission.
11. LIS Project: Nearing completion. Have been able to process information on school reunion booklet finally!
12. Zoning: Public Hearings held for Elzinga and Luckett Special Use Permits. No information available from Planning Commission at this

time. Public Hearing on the Master Plan has been set for Thursday September 12 at 7:30 P.M. Zoning Board of Appeals held hearing on proposal for a lot split by John Pearl and set back variance by Stephen Andrasko July 30. Pearl request was denied. Andrasko was modified and approved after conferencing with the applicant by telephone.

13. Cemetery: Title Search still pending on the Atwood Cemetery.

14. Bills represented by the attached list were presented for approval for payment. MOTION Strange, VanderArk, CARRIED to pay the bills as presented.

15. The meeting was adjourned at 8:50 PM.
