

Banks Township Board Regular Meeting  
July 18, 1994  
held at the Banks Township Hall, Ellsworth, Michigan

1. The meeting was called to order by the Supervisor Daniel Wieland at 7:30 PM. Board members present included Supervisor Wieland, Clerk Donna Heeres, Treasurer Jacob Veenstra, Trustee Peter VanderArk and Trustee Gary Strange. Also present: John Hastings, Jerry Rasmussen, Bill Wiltse.
2. Bill Wiltse addressed the Board about his family's establishing a private cemetery on .25 acre on their farm. After consultation with MTA advisors and review of the material presented by Mr. Wiltse, the consensus of the Board was to draft a letter to Jon Mayes of the DNR stating that the Township Board is aware of the project. A file will be created within the Clerk's records with information including survey.
3. The minutes of the June meeting were read. MOTION Wieland, Veenstra, CARRIED to approve the minutes as presented.
4. The Treasurer's Report of Incomes and Balances was given. General Fund: \$151,578.08; Fire Fund: \$53,011.40; Vehicle Fund: \$12,503.00; Liquor Fund: \$2,215.96; Grand Total: \$219,308.44.
5. Fire Board: No meeting this month. The nozzles have arrived.
6. Township Hall Parking Lot: CB North is verbally willing to deed the back one half of the Bank lot to the Township. The Township has been approached to sell the Watros property for business expansion.
7. Zoning Board of Appeals: Churchfield variance request was denied following public hearing. Request was for reduced setbacks. Thelma Chellis resigned her position following the meeting.
8. Planning Commission: Banks Township Zoning Ordinance amendments were sent to Attorney for review. Public Hearing will be held, then will send to the County Planning Commission for review, with final adoption <sup>by</sup> the Township Board. Proposal for Private Road Ordinance was presented. The Planning Commission recommends the Township Board adopt the ordinance rather than make it a part of the Zoning Ordinance. Tabled until next meeting. Discussion of plans for the Jones property.
9. Township Hall Upstairs Project nearly completed.
10. Election Inspectors: MOTION Heeres, Wieland CARRIED to appoint election inspectors for the August 2 Primary Election. List on file.
11. Bills represented by the attached list were presented for approval for payment. MOTION Strange, VanderArk, CARRIED to pay the bills as presented. General Fund: \$3,612.24; Fire Fund: \$243.89; Grand Total: \$3,856.13.
12. The meeting was adjourned at 9:00 PM.
