

# **Banks Township Board Minutes**

July 17, 2000

1. **Supervisor Daniel Wieland called the meeting to order at 7:30 PM at the Banks Township Hall. Present were Supervisor Wieland, Clerk Donna Heeres, Treasurer Jacob Veenstra, Trustee Peter VanderArk and Trustee Gary Strange. Also Present: John Hastings.**
2. **The minutes of the last regular meeting were presented for approval. MOTION Strange, Wieland, CARRIED to approve the minutes as presented.**
3. **The Treasurer's report of Incomes and Balances was given. General Fund: \$270,229.04; Fire Fund: \$136,823.67; Vehicle Fund: \$13,404.00, Liquor Fund: \$1965.00; Grand Total: \$422,421.71.**
4. **Historical Society: Strange reports he had phone call from members of BTHS on the weekend and has not gotten back with them yet. An appointment with a floor refinisher is to be scheduled soon.**
5. **Roads: John Hastings reported on the door to door campaign for the road millage proposal. Plans for a mailing are also underway. Supervisor reports contact from a business on Bennett Hill road that has requested paving of that road. The request was forwarded to the Roads Committee for consideration.**
6. **Fire Dept: Rescue rig has failed on three recent runs. One was due to operator error in turning on a gas tank. Second was when axle came loose from spring. Third was when the starter failed. All problems have been remedied.**
7. **Township Hall: Clerk reported that Health Dept inspection found some critical deficiencies with the toilets. The problems have been remedied and follow-up inspection passed. Plan to have the septic tank pumped this fall.**
8. **Planning Commission: Minutes of the June 2000 meeting were reviewed. No meeting in July. Awaiting wording revisions before publishing new ordinance.**
9. **Supervisor announced that Equalization Director Dan Bolle has resigned to take a position with Manatron.**
10. **Correspondence: Letter from MTA about membership, thank you from Pig Roast Committee for support, St. Clair Lake/Six Mile Lake Association newsletter, Par Plan Newsletter, application for DEQ permit for Ron Strong, Stop work order issued by DEQ to Drenth Brothers for work in Section 25 R9W on Old Dixie Highway, Sheriff Dept activity report.**

11. **ACNA: Minutes of a meeting held June 5 were reviewed. Veenstra updated on the July 10 meeting.**
12. **Election: Inspector appointments by the Election Commission were approved. Training session for inspectors will be held July 20 in Central Lake with the official school to be held July 24 in Bellaire.**
13. **Cemetery: VanderArk reviewed the need for a new vehicle for use by cemetery & park personnel. Bob's Sunoco has a 1990 Ford F-150 4x2 truck with over 100,000 miles for sale for \$3500 plus title and transfer. MOTION Strange, Wieland, CARRIED to purchase the truck and sell the old one for salvage when the new truck is ready for use. Requested personnel using the truck keep a logbook of trips to substantiate use. Also for reimbursement on personal vehicles to be submitted to Clerk. VanderArk reported that the north driveway at Antrim City is now in need of gravel. He has contacted Hugh Lambert who offered 3 solutions, short of paving it. Decided to contact Drenth's, Mark Groenink, Matt Heeres, and Joe Gates to obtain bids with Clerk authorized to hire lowest bidder to deliver and spread 30 yards of 23-A gravel.**
14. **Bills represented by the attached list were presented for approval for payment. MOTION Wieland, Veenstra, CARRIED to pay the bills as presented.**
15. **The meeting was adjourned at 8:55 PM.**
