

Banks Township Board Regular Meeting

June 19, 1995

held at the Banks Township Hall, Ellsworth, Michigan

1. The meeting was called to order by the Supervisor Daniel Wieland at 7:30 PM. Board members present included Supervisor Wieland, Clerk Donna Heeres, Treasurer Jacob Veenstra, Trustees Peter VanderArk and Gary Strange. Also present: Mark Groenink and Eric Wisniewski of the Antrim County News.

2. The minutes of the May regular meeting were reviewed. MOTION Strange, VanderArk, CARRIED to approve the minutes as presented.

3. Old Business: Supervisor reports that improvements to Premore Road have been put on hold for now by the Property Owner.

4. The Treasurer's report of Incomes and Balances was given.

5. Fire Board meeting was held earlier this evening. Estimate for repairs and repainting of #6620 is \$3078. MOTION Wieland, Strange, CARRIED to approve the repainting proposal. Discussion re: need for new monitors. Cost \$325 each. Will check to see if discount is available for multiples purchased at the same time. Sealed blue prints for the proposed Atwood Fire Hall were reviewed. Mark will have specification sheet and copies made for distribution. Plan to open bids at July 17 meeting. Reported problems with dispatching and tower mal-functions.

6. Planning Commission: No meeting was held in June.

7. Roads: Supervisor reports that the road between Carpenter Road and Doctor Road along the Antrim/Charlevoix County line needs a name. MOTION Wieland, VanderArk, CARRIED to pass a resolution to name this road Skinner Road. YEAS: 5, NAYS: None.

8. IDC Property Update: Meetings were held June 14 in Ellsworth with contractors and the DNR in the afternoon, the public and the DNR at night. Information re: cleanup plans was outlined.

9. Jones Property: Meeting held on May 31 with Preliminary review of the Grant Application by the DNR. Representatives will visit the site on June 28. The Committee will meet in Petoskey on August 15 to make the final determinations.

10. Clean Up Day: June 10. 20% more volume collected. Cost is \$8474, up \$821 over 1994.

11. Township Vehicle: Discussion re: purchase of a pickup truck to haul cemetery mowers, picnic tables, etc. Wieland

will contact Bob Vollmer to investigate the availability.

12. Clerk reported on followup on Zoning Violations on which agreements were reached but the violation still exists. The Zoning Administrator's report on Blight Ordinance Violations was reviewed. Discussion re: road side signs and need for regulation.

13. Trophy Case: Bid of \$483.20 by Maine Woodworks was reviewed. Village has agreed to pay one half of the cost. MOTION Strange, Wieland, CARRIED to pay the other half and have it installed in the entry of the Township Hall.

14. Antrim Area Seniors, Inc.: Letter requesting millage vote at the next election. Clerk to contact Ray Mills to attend a meeting & explain.

15. Bills represented by the attached list were presented for approval for payment. MOTION Strange, VanderArk, CARRIED to pay the bills as presented.

16. The meeting was adjourned at 9:10 PM.
